**PARKING DECAL- \$70.00**

*Parking decals can be purchased from the bookkeeper's office, during the summer, starting July 10, from 9am-12pm daily. Decals will also be on sale during Orientation, August 2<sup>nd</sup>, from 12-2pm and will then go back on sale on the first day of school, during break during lunch, and after school until 2:45 P.M. only.*

In order to park on campus, students must complete the following:

1. Clear all student debt with the bookkeeper.
2. Complete the application on the back of this form.
3. Provide a copy of the vehicle registration.
4. Provide a copy of the student's valid driver's license.
5. Provide cash or check for the full amount, made payable to "Lyman High School".
6. Place the parking sticker on the lower left hand side of the windshield so that it is easily visible.

Students parking on campus must adhere to the following parking guidelines:

1. Student parking is only permissible in the following parking lots.
  - a. South lot behind building 4 - in the rows marked "student parking"
  - b. Between buildings 10 and 11
  - c. On the side of building 12 in front of the practice field.
  - d. Parking in the paved lot next to the auditorium is reserved for students with OJT or that need to leave early for SSC Dual Enrollment.
2. Do not park in visitor or staff parking spaces.
3. Do not park on the grass or block any sidewalks or roadways.
4. Adhere to the campus-wide 15 miles per hour speed limit.

NOTE: If the vehicle is sold or becomes undriveable, remove the sticker, bring the old sticker to the Bookkeeper where it will be exchanged for a new one at no cost.

Parking on campus is a privilege, which can be taken away for non compliance with the district code of conduct. Parking stickers are non transferable.

Students parking on campus WITHOUT a decal, or found in violation of the above stated rules, will receive the following consequences:

- **1<sup>st</sup> offense** - Warning sticker attached to the driver's window.
- **2<sup>nd</sup> offense** -Warning sticker attached to the driver's window and parent contacted. A written referral will be issued and recorded.
- **3<sup>rd</sup> offense**- Vehicle towed at the owner's expense.
